I. REPORTS OF THE CORPORATION CHURCH COVENANT

That should we move from this community we will as soon as possible unite with some other church, where we can carry out the spirit of this covenant and the principles of God's word.

MINUTES OF THE 184TH ANNUAL MEETING FEBRUARY 17, 2013

The 184th Annual Meeting of the First Baptist Church of Bennington, Vermont was called to order at 10:45 AM by Moderator, Wayne Kachmar.

The Agenda to vote on is the ratification of Trustees members to transact any other business. Allyn Lindsay made a motion to accept and Susan Hoag seconded it. The motion was carried. It was announced that there were no By-Law changes.

Business:

The minutes of the 183rd Annual Report as written in the annual Report had a motion made by Ralph Rockwell to accept as written and was seconded by Cindy March. The motion was carried.

A question was raised by Aleta Bryant-Boutin, as to "who gave the Office manager permission to choose the color of paint for Colgate Hall?." It is believed that the Congregation should have been presented with the task and a discussion should have followed. The Moderator stated the Board of Trustees had appointed the (non-member) Melissa Hepler with this task. There were many congregants who were very disappointed in the fact that they did not have a choice in this matter. There seems to have been a breakdown in communication by the Board of Trustees. The Moderator apologized for the oversight. Aleta Bryant-Boutin stated, "The church consists of the people and not just the administrative staff, the Pastor and committees must work together".

Pledges:

Byron Spafford reported that pledges were down due to the economy and reported there were; \$38,500 in pledges for local expenses, \$7,560 for Benevolence (Mission) and \$5,458 for the building fund.

Budget:

Discussion followed in regard to the budget as presented. Because of the rising cost of insurance, taxes, etc. The following measures were taken;

The pastor has been charged with a 25% increase of his health insurance premiums. (The pastor had not taken an increase of salary for 2013.). Taxes have risen for the Sexton property. According to the budget in the annual report for 2012 –expenses far outweigh the income, even when the \$78,000 interest from the Endowment Funds were factored in. **The deficit is at \$6,114.39.** Someone in the congregation suggested a breakdown of staff salaries, because the budget did not reflect individual salaries. Four people on the payroll reflect \$81,679.03 being paid out. The Sexton is at 20 hours a week. The playroom supervisor is at 2 hours a week. The office manager is at 30 hours per week. The pastor's salary is the balance. The response from Grace Becker-Wilson was, "Anyone interested, is welcome to see the break down."

The report of the Endowment Fund showed the growth from 2010-2011.

Nominating Report:

Since the Nominating Committee has been disbanded as such, a question was asked as to who does the nominating, Moderator Wayne Kachmar said that is consisted of the Church Officers, the Moderator, Committee heads and the Church Clerk. (Of which the clerk was never approached for input). The Church Life Board has combined all the other boards, ie: Christian Education and Missionary Boards. There were motions proposed by Susan Hoag to add two more names to the Church Life Board. Rhonda Harmon and Aleta Bryant-Boutin. This was seconded by Josie Shepard. The motion was carried.

It is noted that the position of Treasurer is open and will accept nominations to the Moderator and the Board of Trustees. The latter in charge of all check to signed. The duties include reporting the budget to the Trustees and match payouts to the budget line items. The treasurer would also be required to sit with the financial consultant, Michelle Marchetti.

Cindy Marsh made a motion to accept the slate of officers, with the addition of two names to the church Life Board. Allyn Lindsay seconded this motion. The motion was carried.

Grace Becker-Wilson made a motion to cast the ballot for the slate of officers as amended. Hattie Hustler seconded this and the motion was carried.

The Sunday Tellers that count the weekly offering, are in need of two more volunteers. It was also noted and given a round of applause and appreciation for Marion Riddle, who has served as a teller since 1974. The slate of volunteers is as follows: Hattie Hustler, Lisa Flynn, Aleta Bryant-Boutin, Barb Cota, Dawn Bushey and Leslie Johnson. The last three pending their approval to serve. A motion was made by Byron Spafford to accept the tellers as listed. Grace Becker-Wilson seconded this and the motion was carried.

As a way to keep the congregation informed of projects being done, it was suggested by the Moderator Wayne Kachmar, to have committee heads announce on Sundays after the service when the general announcements are being made. There does seem to be a lack of communication between the church boards and the congregation.

Ralph Rockwell made a motion to adjourn and Julie Blake seconded it. All were in favor and the motion was carried.

Coordinating minister-pastor Jerrod Hugenot offered a closing prayer and grace for the potluck luncheon to follow.

III. REPORTS OF THE OFFICERS REPORT OF THE MODERATOR

This past year has been a year of changes for First Baptist Bennington. Both the Trustees and Church life boards have started to develop their roles under the updated bylaws and have developed a better understanding of their roles in governing the life of the church. The various committees that are necessary to the running of the church have been infused with new volunteers and many who for many years have volunteered their time in these committees are helping new members to learn the duties and responsibilities of the committee or task force. That said there is still a need to add new volunteers across all boards and committees. In the midst of this year we had our minister accept a new call to assist in supporting the Baptist churches in the New York state region. With his departure we formed a search committee to start the process of discerning a call for a new pastor and interim minister. To that end the committee was formed. During the summer we had the experience of hearing from many interim ministers each at many places in their faith journeys. During this time the congregation rededicated itself to the life of the church with many stepping up to help in worship services, increase the activities of the boards and committees, serve on the search committee, or provide help in many different ways that help make First Baptist Bennington special. With the arrival of Rev. Thomas Hiltsley in the beginning of Advent, we were able focus on the next steps in preparing to call a pastor.

The trustees have taken a proactive approach to stewardship of the endowment and management of the physical plant, including both the sanctuary and parsonage, and developed a cadence of meetings to transact the churches business. The physical plant is in reasonable condition and does not dominate our discussions or planning time any longer. Our cost share space is well utilized with active charities we support and they are needed in our community. As always we continue to be surprised by the needs of an aging physical plant. One look at the trustees report shows the proactive efforts now being undertaken to shore up these issues.

Spiritually the missional church pathway we are now on has helped us stay focused on the basic human needs of those in our community. In addition, the activities which go on in our buildings, both within the congregation and in the wider world of other charitable organizations housed here are clear evidence that we want to share our blessings with those around us in need. We have truly stated to blend the lines between traditional church and missional church activities as we have embraced our new identity. Our cost share partners are making a difference in our community! When discussions about basic human needs are brought up in town, First Baptist is often mentioned as the resource of ideas, space and willingness to help work on these issues. We have taken the biblical directive to be good stewards of all that we are given and translated it into action. Our facilities now are working 7 days a week in a sustainable model.

As we move into 2014 with much of the basic structure of the church on solid footing, we can use our time with our interim minister to build on the foundation the past few years of change has brought. Helping to discern what is the right path for ministry in First Baptist Bennington and with God's help finding that pastor that is right for us when our interim pastor's time is completed. This may include a strategic plan for the church, building leadership continuity (training, focus, etc.).

As we move forward there are many storm clouds on the horizon: Less and less free time of our congregants, more government oversight and reporting requirements, increased need locally and in the wider world. Increases in the costs of heating oil, electricity, and gas have become the norm and sustainable planning is critical to our survival.

Looking toward this New Year we and the journey we have started there is still much to do. The search committee has much work ahead now that our interim time (2 years) has started. There may be some difficult times and some blessings along the way, as we try to follow on the path God has set before us. We pray for his continued guidance as we face these challenges.

The search committee had many things to accomplish in the past nine months since the committee was formed. For those who do not know, Lisa Flynn and Susan Kachmar have shared the chairperson duties. And we have had the expertise of Allyn Lindsey, Milt Surdam and Mike Munson. We started working in spring and filled the pulpit during our time without any minister here. We reviewed ministerial profiles, interviewed candidates, and then chose Tom. But our work is not over as we still need someone for our permanent minister. We will begin this new year to seek God's will for us, identifying ourselves as a faith community, observing our changes over the past years and make decisions about how we still need to change in the future.

REPORT OF THE BOARD OF TRUSTEES

This year, the Board of Trustees focused on financial cost savings. This was achieved by things such as implementing energy management programs and community volunteers. In the beginning of 2013, we had a 10% draw on our endowment (\$93,000). On top of the endowment issue, we did not anticipate the revenue shortfall that would come from the loss of Easter Seals as our tenants during the year. This alone was \$11,610.

This year's budget went down to 7% sustainability (\$6,500 a month draw) from the endowment. This figures to be a savings of \$15,000 over last year's budget. This is included adding in a salary for a Sunday School teacher.

We worked on reducing our fuel consumption by making some changes. We did this by installing programmable thermostats in the church. We also replaced several windows in the parsonage to help reduce heating costs as well. Additionally, we received a \$10,000 Energy Management grant this year that will help us reduce our costs in the future.

Volunteers from our community, donating their time to help complete projects have helped reduce costs that go along with general upkeep of the church. Volunteers from the community saved the church approximately \$6,280 in expenses. Various projects were: mowing the lawn, painting rooms and cleaning around the church. The board expresses thanks to Dale Coppin and the Twilight Program for painting the common areas of the church and to Aaron Burke who maintained the lawn and church surrounds throughout the spring and fall.

Our focus in 2014, is to continue to implement the use of Community Service type projects to help improve the condition of the church. This will help the church get more cost sharing partners to fill the vacant rooms. We will continue to seek the advice our new financial advisor, Gregory Smith, who will continue to help guide us by giving us strategies to help manage our endowment in the future.

The increase in the endowment funds reflects the upward trend in the 2013 stock market combined with the decrease of withdrawals made by the church this year to cover expenses. The decrease in Money Market #831 is due to withdrawal's that went towards repairs and improvements to the annex (front door replacement, fire system upgrades and masonry work) and the parsonage floor refurnishing. It was decided to remove money from this account that earns no interest vs the building fund which earns dividends. The increase in money market #376 reflects the decrease of withdrawals from the endowment in 2013.

COURT TRUSTS

First Baptist moved the endowment portfolio into the care of the American Funds in 1999. The four court trusts given by the estates of congregants Nichols, White, Edgerton, and Harris, had terms stipulating dividends were to be paid to the congregation on a quarterly basis. The Nichols and the White Trust dividends are used for property upkeep expenses. The Edgerton and Harris Trusts are used for the work of Christian education.

The White, Nichols, Edgerton, and Harris trusts are lodged in the Capital Income Builder, generating quarterly dividends listed in the 2013 budget. Upon receipt of quarterly dividends, the Board of Trustees reviews the expenses paid out by the church's general account for costs related to building operations and upkeep and religious education programming and personnel. We give thanks for the continuing generosity of these congregants now deceased.

REPORT OF THE FIRST BAPTIST CHURCH'S MEMORIAL FUND

In 1976 our Board of Trustees set up a Memorial Trust Fund. As memorial contributions, either undesignated or specifically designated to this Fund, are received they are placed in a special savings account, with other investment mediums used when sums warrant. From time to time these funds are used to make special purchases, which will benefit the church.
